Dear Ladies and Gentlemen:

I am the General Counsel of Gannett Media Corp. ("Gannett"). Telegram & Gazette is a member of Gannett family of publications.

It has come to our attention that *turtleboysports.com* has used content and/or photographs from stories and other exclusive content published and owned by Gannett specifically the Telegram & Gazette). Examples of such content, as they appeared on your website recently, are set forth in <u>Exhibit A</u>, attached hereto.

We wish to advise you that the content and/or photographs that you are copying are the copyrighted property of Gannett, and that your copying constitutes infringement of Gannett's rights under U.S. Copyright law. This infringement is not excused by links to the original stories or by indicating the name of the publication in which the content originated.

We further believe that your use of Gannett content does not qualify as "fair use" under U.S. Copyright law because wholesale copying is being done solely for commercial purposes, in a manner that is highly prejudicial to Gannett's business and because the copied material constitutes the totality of the news stories.
