NARRATIVE

About 10:14am on Friday, 03/18/22, Officer Keogh in the K426D responded to a call from a concerned citizen for an attempted breaking and entering into vehicles at 426 Faneuil Street, Brighton. Officers Walton & Caron in the K104D also responded to assist.

The witness, [REDACTED], called Officer Walton's cell-phone and stated that [REDACTED] saw a [REDACTED] walking down Faneuil Street pulling door handles to various vehicles, attempting to open doors. [REDACTED] stated that the suspect was heading towards Kiki's Kwik-Mart located at 236 Faneuil Street, Brighton in the direction of Arlington and Faneuil Street.

Upon arrival, Officer Keogh was flagged down by [REDACTED] who was standing in front of Kiki's next to a pickup truck, pointing over the roof of the truck towards a group of four individuals. [REDACTED] stated that [REDACTED] observed a [REDACTED] walking down Faneuil Street attempting to open car doors. [REDACTED] pointed at a Gold Lexus SUV parked on Faneuil Street and stated that the suspect had opened and closed the door to that Lexus and had tried to open the doors of two other cars parked behind the Lexus. Officer Keogh observed

the suspect, later identified as [REDACTED] with three other [REDACTED] later identified as [REDACTED] and [REDACTED] walking away from Kiki's, down Faneuil Street in the direction of the Mary Lyons School.

Officer Keogh stopped the group and asked for [REDACTED] identification, to which [REDACTED] stated [REDACTED] did not have one. Officer Keogh asked for [REDACTED] name and date of birth, which [REDACTED] provided. CJIS inquiry of [REDACTED] revealed that [REDACTED] had an outstanding warrant out of Suffolk County Juvenile Court (03/10/22) for Unlawful Possession of a Firearm (MGL c. 269, s. 10(h)) and Unlawful Possession of Ammunition (MGL c. 269, s. 10H), Docket No. 21DL0099BO, Judge Peter Coyne. Officer Keogh placed [REDACTED] under arrest and called for additional units. Officer Keogh, concerned for his safety due to the nature of the warrant and being outnumbered, ordered [REDACTED] to sit down on the curb and ordered [REDACTED] and [REDACTED] to stand away until additional units arrived.

Officers Walton & Caron in the K104D responded and assisted conducting CJIS inquiries of [REDACTED] and [REDACTED] none of which had identification. CJIS inquiry revealed that [REDACTED] and [REDACTED] did not have any active warrants or restraining orders. [REDACTED] initially refused to provide [REDACTED] name or date of birth. While attempting to conduct CJIS inquiry, a [REDACTED] who initially identified [REDACTED] as [REDACTED] arrived to the scene and stated [REDACTED] had observed [REDACTED] and [REDACTED] "sitting quietly" at Kiki's and inquired about the caller's race. [REDACTED] refused to assist Officers identify [REDACTED] and refused to identify [REDACTED] to Officers. [REDACTED] asked if the caller was white and stated "of course you will believe them." [REDACTED] stated "funny we are all paid from the same payroll." [REDACTED] stated [REDACTED] had "distrust issues" with Officers and continuously made comments about the Officers being white. While [REDACTED] was eating a breakfast sandwich, [REDACTED] told Officers that the group did not do anything.

[REDACTED] was continuously within close proximity (under 5 feet) to Officers while they were attempting to conduct a police investigation. [REDACTED] continuously interrupted Officers while they attempted to conduct their investigation, obstructed Officers from doing their investigation and distracted Officers when they were pat-frisking [REDACTED]

While attempting to conduct CJIS inquiry, a [REDACTED] who identified [REDACTED] as an [REDACTED] of [REDACTED] [REDACTED], arrived to the scene and assisted Officers in identifying [REDACTED]. While Officers were talking with [REDACTED] [REDACTED] asked [REDACTED] specifically not to provide Officers with [REDACTED] name or identification.

While attempting to conduct CJIS inquiry, [REDACTED] ran across Faneuil Street from the direction of Oliveira's Deli Market (243 Faneuil Street, Brighton) and began screaming at officers. [REDACTED] was yelling about why [REDACTED] was under arrest and began filming with [REDACTED] cell-phone. [REDACTED] yelled that Officers "were waiting at [REDACTED] door" and were going to follow [REDACTED] throughout the day. [REDACTED] became increasingly confrontational when [REDACTED] was informed [REDACTED] was being arrested for an outstanding warrant and screamed "Racist Motherfuckers" at Officers. When Officers told [REDACTED] that [REDACTED] had been observed attempting to open car doors, [REDACTED] responded and said that [REDACTED] other [REDACTED] was in Court and that [REDACTED] was not the one who did that.

Another unknown individual and unidentified [REDACTED] then arrived on scene and began asking Officers what was going on.

Officers conducted a pat frisk of [REDACTED] torso and legs down to the knees and placed [REDACTED] in the back of the K426D. The scene was continuously escalating with [REDACTED] and [REDACTED] interrupting and distracting Officers from completely pat frisking [REDACTED]

[REDACTED] was transported back to D14 for booking. During the booking search, Officers discovered a loaded Bersa .380 caliber firearm with four rounds in the magazine (no round in the chamber) tucked within [REDACTED] right high-top sneaker. The Bersa had a partially obliterated serial number [REDACTED] and black electrical tape on the handle.
