On October 21, 2022, I, Officer Domingas Gomes was assigned to the Uniform Division, Day Watch, Sector #10. At approximately 10:51 AM, I was dispatched to 380 Fifth Street Apartment #1 regarding an assault and battery incident that occurred two days ago. Officer Aaron Souza responded to assist.

Upon arrival, we were let into the apartment by Jasmine Ferreira (DOB: 3/19/94). Jasmine stated she was assaulted by a female named Cassidy Levitre (DOB: 8/31/97). She said she knows of Cassidy because her child's father used to deal with her. Jasmine said this incident happened two days ago on Wednesday, October 19, 2022, at approximately 3:30 PM. Jasmine said she was walking up Branch Street to her daughter's bus stop on John Street to wait for her daughter to arrive from school. She said Cassidy happened to be parked on Branch Street as she was walking. As soon as she passed Cassidy's vehicle on Branch Street, Cassidy started to yell from her car. Cassidy started to harass Jasmine as soon as she saw her. Cassidy called her names, such as "dusty ass bitch". Cassidy also yelled that she was going to beat her up. Jasmine said she responded by saying that she had to go pick up her daughter from school, to leave her alone. Jasmine continued to walk up the street and Cassidy drove around the area to catch up to Jasmine, who had turned on John Street, which is a one-way. Cassidy abruptly parked her vehicle on John Street as soon as she was near Jasmine again and jumped out of her car and started swinging her arms at Jasmine. Jasmine stated Cassidy had a hand cast and struck her in the face with it multiple times. Jasmine said the attacks came from Cassidy's hand and pink hand cast.

I observed Jasmine's face and saw that she had multiple scratches and bruises. No Rescue was needed. I asked Jasmine why she did not report the incident that same day and she stated she did not want to get the police involved at first. She said Cassidy continued to harass her on social media (Facebook). She said Cassidy also posted a video of her and her daughter walking back home after she had assaulted her. The video has been attached to this report as evidence. Cassidy states clearly in the video that she physically assaulted Jasmine. Jasmine also stated that Cassidy continued to make threats toward her. The Facebook messages that Cassidy sent to Jasmine are also attached to this report as evidence.

The threats that were made toward Jasmine by Cassidy were as follows;

- "I didn't do nothing my cast did (laughing emoji)."
- "Coulda did more without it."
- "Gimme 3 weeks I got you."
- "I know where you stay and where you pick your kid up now so it's nothing. Don't lack baby."
- "I'll see you again soon make sure you ice that nose (laughing emoji)."

Cassidy also admitted to physically assaulting Jasmine in the video attached to this report. The video was made by Cassidy and posted to her Facebook page. Shortly after posting the video, Cassidy took it down but Jasmine was able to retrieve it while it was still on her Facebook page. In Cassidy's video, she admits to the following:

<sup>&</sup>quot;Caught you at the stop light."

<sup>&</sup>quot;Haha, look at your face, haha."

<sup>&</sup>quot;Your nose and everything, haha."

<sup>&</sup>quot;All you bitches that is mad about me posting what I'm posting, ask that bitch how it felt to get one of these to the fucking face." (as Cassidy was showing her hand that had the cast)

<sup>&</sup>quot;A busted bitch got busted up. I'm satisfied and handicapped."

I contacted Cassidy via phone before seeing the videos and messages she sent to Jasmine. I asked Cassidy about the incident and Cassidy denied everything. Cassidy was very uncooperative on the phone and she hung up at the end of the call.

I checked with St. Michael Driving School on Plymouth Avenue for video surveillance of the incident, I spoke to Joe DaSilva, who is the manager and he stated they do not have cameras. Jasmine stated the incident occurred right outside of their business building. I also had advised Jasmine to seek a harassment order against Cassidy. Jasmine stated she will go to the courthouse to request one.

Cassidy has had several arrests due to Assault and Battery on other individuals in the past as well as Assault and Battery with a Dangerous Weapon.

Based on the events as told and shown by Jasmine, I respectfully request a warrant to be issued for the arrest of Cassidy Levitre (DOB: 8/31/97) for the following charges;

MGL 265/15A/A Assault and Battery with Dangerous Weapon, to wit hand cast MGL 265/43/A Stalking
